The Kern County District Attorney's Office Child Abduction Unit needs the public's help in finding two children who were abducted by their mother on November 10, 2018. The children, Zerenity and Anthony Coleman, were abducted by their mother, Zachiah Pratt, who does not have custodial rights.

Zerenity is 21 months old, and is described as a black female, 3 feet 5 inches tall, 22 pounds, with black hair and brown eyes. Anthony is 11 months old, and is described as a black male, 3 feet tall, 14 pounds, with black hair and brown eyes. Pratt is 21 years old, and is described as a black female, 5 feet 7 inches tall, 185 pounds, with black hair and brown eyes.

Zerenity and Anthony are considered at risk and are believed to be in the Bakersfield or Shafter area. On December 18, 2018, a felony warrant was issued for Pratt for charges PC 278: child stealing, PC 278.5: child concealment, and PC 166(A)(4): contempt of court.
