

**WWLS “2024 68 TEAM GIVEAWAY” CONTEST  
OFFICIAL RULES**

A complete copy of these rules can be obtained by contacting radio station WWLS (“Station”), **4045 NW 64<sup>th</sup> St. #600 Oklahoma City, OK 73116**, during available business hours Monday through Friday, on the Station website [www.thesportsanimal.com](http://www.thesportsanimal.com), or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the “**2024 68 Team Giveaway**” Contest (the “Contest”) substantially as described in these rules, and by participating, each entrant agrees as follows:

- 1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.**

**Eligibility.** This Contest is open only to legal U.S. residents of the Station’s Designated Market Area (“DMA”) as defined by Nielsen Audio, age eighteen (18) years or older at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last ninety (90) days or a prize valued at \$500 or more in the last six (6) months, and whose immediate family members or household members have not won a prize from the Station in the last ninety (90) days or a prize valued at \$500 or more in the last six (6) months. **Void where prohibited by law.** Employees of Station, Cumulus Radio LLC, and each of their parent companies, affiliates, related entities and subsidiaries, promotional sponsors, prize providers, advertising agencies, other radio stations serving the Station’s DMA, and the immediate family members and household members of all such employees are not eligible to participate. The term “immediate family members” includes spouses, parents and step-parents, siblings and step-siblings, and children and stepchildren. The term “household members” refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant’s full and unconditional agreement to these Official Rules and Station’s decisions, which are final and binding in all matters related to the Contest. Winning a prize is contingent upon fulfilling all requirements set forth herein.

- 2. Contest Period.** The Contest period will begin at **2:00pm CT on March 19<sup>th</sup>, 2024** and will run through **11:59pm CT on April 8<sup>th</sup>, 2024** (the “Contest Period”). The Station’s computer is the official time keeping device for this Contest.

- 3. How to Enter.**

Attend the remote broadcast conducted by the Station from 2 PM CT to 7 PM CT on March 19th, 2024 at Twin Peaks, 6500 SW 3<sup>rd</sup> Street, Oklahoma City, OK, and complete an official entry form. **Limit one (1) entry per person per remote broadcast.** All entries must be received by the deadline stated at the remote broadcast.

**If the remote broadcast is temporarily postponed or permanently cancelled due to disease, epidemic, pandemic, quarantine, any acts of government and/or any reason that is beyond the control of Station or Cumulus Radio LLC (“Sponsor”), then no substitution shall be provided by Station or Sponsor. Station and Sponsor make no representation or warranty about the safety of the remote broadcast in light of COVID-19. By attending the remote broadcast, participants acknowledge the risk of large group gatherings and assume all risks of attending a remote broadcast, including any and all repercussions associated with attending the remote broadcast.**

- 4. Winner Selection.** At the remote broadcast and beginning after 4:00pm C.T. on Tuesday March 19<sup>th</sup>, 2024, Station will randomly draw one entry approximately every (60) sixty seconds during commercial breaks and the person selected will then choose one (1) envelope out of the available sixty-eight (68) envelopes displayed on a bulletin board. The sixty-eight (68) envelopes represent the sixty-eight (68) seeds/teams in the 2024 Men’s College basketball tournament. This process will continue until all 68 envelopes have been selected. If an entrant’s name is not called, they will be qualified to win a “last

chance” prize at the end of the drawing. If a registered entry is not announced after the last chance drawing, they are disqualified from further participation in the Contest. Each envelope holder will be assigned one Division I men’s basketball team identified on the paper inside the envelope he/she chose for the duration of the 2024 Division I Men’s Basketball Championship (the “Championship”). All team assignments are final. Team assignments will be recorded and maintained by the Station for the duration of the Contest.

**ENTRANTS MUST BE PRESENT TO QUALIFY. NO PROXIES WILL BE ALLOWED FOR ANY REASON.** The qualifying 68 entrants will be announced over the public address system during the remote broadcast at Twin Peaks only (subject to verification of eligibility and compliance with the terms of these rules). Qualifiers will not be announced over the air.

There will be four (4) prizes awarded: one (1) Grand Prize and three (3) Runner Up Prizes. The Grand Prize winner of this Contest will be the entrant whose assigned team wins the 2024 Division I Men’s Basketball Championship and the Runner Up Prizes will be awarded to the entrants whose assigned team are the remaining (3) three runner ups in the 2024 Division I Men’s Basketball Championship based on seeding. All winners will be contacted by the Station within seven (7) business days of the final championship game on April 8, 2024, using the contact information provided in the official entry form. Station’s decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification will result in disqualification.

**5. Verification of Potential Winner.** THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST. The potential winner must continue to comply with all terms and conditions of these Official Rules, and winning is contingent upon fulfilling all requirements. The potential winner may be notified by email and/or telephone call after the date of random drawing and/or winner determination. The potential winner will be required to sign and return to Station, within three (3) days of the date notice is sent, an affidavit of eligibility and a liability/publicity release (except where prohibited) to claim the prize, if applicable. A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize. If a potential winner cannot be contacted, fails to sign and return the affidavit of eligibility and/or the liability/publicity release within the required time period (if applicable), or if the prize or prize notification is returned as undeliverable, potential winner forfeits prize. In the event that the potential winner of a prize is disqualified for any reason, Station may award the applicable prize to an alternate winner by random drawing from among all remaining eligible entries. Unclaimed prizes may not be awarded.

**6. Prizes.** One (1) Grand Prize and three (3) Runner Up Prizes will be awarded in this Contest.

(a) Grand Prize winner will receive (i) One (1) American Eagle Patriot 60’ Basketball goal with delivery and installation included (the Approximate Retail Value (“ARV”) is Two Thousand Three Hundred and Ninety-Nine Dollars (\$2,399.00), plus one (1) Napoleon Rogue Grill (the Approximate Retail Value (“ARV”) is One Thousand and Ninety-Nine Dollars (\$1,099.00)

**The Total ARV of the Grand Prize is Three Thousand Four Hundred and Ninety-Eight Dollars (\$3,498.00).**

(b) Runner Up Prize winner number 1 (2<sup>nd</sup> place) will receive one (1) Project Sgt. Pepper Essential III Turntable (the Approximate Retail Value (“ARV”) is Five Hundred Dollars (\$500.00) and one (1) set of Kanto YU4 Powered speakers (the Approximate Retail Value (“ARV”) is Four Hundred and Nineteen Dollars and Ninety-Nine cents (\$419.99)

**The Total ARV of the Runner Up Prize #1 is Nine Hundred Nineteen Dollars and Ninety-Nine cents (\$919.99).**

(c) Runner Up Prize winner number 2 & 3 (3<sup>rd</sup> and 4<sup>th</sup> place) will receive one (1) Neurofeedback Brain Mapping from Brain Train Center (the Approximate Retail Value (“ARV”) is Five Hundred Dollars (\$500.00)

**The ARV of the Runner Up Prize #2 and #3 is Five Hundred Dollars (\$500.00).**

**TOTAL ARV OF ALL CONTEST PRIZES IS: Five Thousand Four Hundred Seventeen Dollars and Ninety-Nine cents (\$5,417.99)**

The winners are responsible for all taxes associated with prize receipt and/or use. Odds of winning a prize depend on a number of factors including the number of eligible entries received during the Contest Period and listeners participating at any given time.

There is no substitution, transfer, or cash equivalent for prizes, except that the Station may, in its sole discretion and to the extent permitted by law, substitute prizes of comparable value or cash. The prizes are expressly limited to the item(s) listed above and do not include taxes, gratuities or any other expenses. Any tickets and/or gift certificates/cards awarded as part of a prize will be subject to the terms and conditions set forth by the issuer and are valid only on the date(s) printed on the tickets or gift certificates/cards. Other restrictions may apply.

If any prize or a portion of any prize is postponed, cancelled, or otherwise unavailable due to disease, epidemic, pandemic, quarantine, any acts of government and/or any reason that is beyond the control of Station or any Sponsor, then no substitution shall be provided. Station and any Sponsors make no representation or warranty about the safety of any prize. By accepting and using a prize, each winner acknowledges and assumes all risks of accepting and using the prize, and any other risks associated with the prize.

7. **Entry Conditions and Release.** By entering, each entrant agrees to: (a) comply with and be bound by these Official Rules and the decisions of the Station and Sponsor(s), which are binding and final in all matters relating to this Contest; (b) release and hold harmless Station, Sponsor(s), Cumulus Media New Holdings Inc., and each of their affiliated companies, participating sponsors, the prize suppliers and any other organizations responsible for sponsoring, fulfilling, administering, advertising or promoting the Contest, and each of their respective past and present officers, directors, employees, agents and representatives (collectively, the “Released Parties”) from and against any and all claims, expenses, and liability, including but not limited to negligence and damages of any kind to persons and property, including but not limited to invasion of privacy (under appropriation, intrusion, public disclosure of private facts, false light in the public eye or other legal theory), defamation, slander, libel, violation of right of publicity, infringement of trademark, copyright or other intellectual property rights, property damage, or death or personal injury arising out of or relating to a entrant’s entry, creation of an entry or submission of an entry, participation in the Contest, acceptance or use or misuse of prize (including any travel or activity related thereto) and/or the broadcast, exploitation or use of entry; and (c) indemnify, defend and hold harmless the Released Parties from and against any and all claims, expenses, and liabilities (including reasonable attorneys’ fees) arising out of or relating to an entrant’s participation in the Contest and/or entrant’s acceptance, use, non-use or misuse of the prize.
8. **Publicity.** Participation in the Contest constitutes entrant’s consent to use by the Station and its agent of entrant’s name, likeness, photograph, voice, opinions, entry, and/or biographical information (including

hometown and state) for promotional purposes in any media, worldwide, without further payment or consideration, unless otherwise prohibited by law.

- 9. Taxes.** All State, Local, Federal and/or other taxes, duties, tariffs, title fees, licensing fees, or other fees for prizes awarded become the sole responsibility of the winner. All those who win a prize or prizes valued \$600 or more in any given year will be issued an IRS Form 1099 to report their winnings.
- 10. General Conditions.** Station reserves the right to cancel, suspend and/or modify the Contest, or any part of it, if any fraud, technical failures or any other factor beyond Station's reasonable control impairs the integrity or proper functioning of the Contest, as determined by Station in its sole discretion. Station reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Contest or to be acting in violation of these Official Rules or acting in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Contest may be a violation of criminal and civil law, and, should such an attempt be made, Station reserves the right to seek damages from any such person to the fullest extent permitted by law. Station's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
- 11. Limitations of Liability.** The Released Parties are not responsible for: (a) any incorrect or inaccurate information, whether caused by Station, Sponsor(s), entrants, printing errors or by any of the equipment or programming associated with or utilized in the Contest; (b) technical failures of any kind, including but not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software; (c) unauthorized human intervention in any part of the entry process or the Contest; (d) technical or human error that may occur in the administration of the Contest or the processing of entries; or (e) any injury or damage to persons or property that may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Contest or receipt or use, non-use or misuse of any prize. No more than the stated number of prizes will be awarded. In event that a production, technical, programming or other error causes more than stated number of prizes as set forth in these Official Rules to be claimed, Station reserves the right to award only the stated number of prizes by a random drawing among all legitimate, unawarded, eligible prize claims.
- 12. Disputes.** Entrant agrees that: (a) any and all disputes, claims and causes of action arising out of or connected with this Contest, or any prizes awarded, shall be resolved individually, without resort to any form of class action; (b) any and all disputes, claims and causes of action arising out of or connected with this Contest, or any prizes awarded, shall be resolved exclusively by the United States District Court or the appropriate state court located in the Station's listening area; (c) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Contest, but in no event attorneys' fees; and (d) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. **SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE MAY NOT APPLY TO YOU.** All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of entrant and Station in connection with the Contest, shall be governed by, and construed in accordance with, the laws of the state in which the Station is located, without giving effect to any choice of law or conflict of law rules (whether of the state in which the Station is located or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the state in which the Station is located.
- 13. Entrant's Personal Information.** Information collected from entrants is subject to Station's Privacy Policy, which is available on the Station's website under the "Privacy Policy" link. All entry blanks, forms, devices, and materials gathered during the course of entry, as well as all information contained therein,

shall become the sole property of Station to be used, disposed of or destroyed in its sole discretion. Station is not responsible for any incorrect or inaccurate information entered by website users, and assumes no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to Station's website.
