95.5 NASH ICON'S "KENTUCKY KINGDOM TICKETS" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station WSM-FM ("Station"), owned and operated by Cumulus Broadcasting LLC located at, 10 Music Circle East, Nashville, TN 37203, during normal business hours Monday through Friday or by sending a self-addressed, stamped envelope to the above address.
