95.5 NASH ICON'S "SUPERSTAR SPRING TICKET GIVE-A-WAY – WEEK OF 4/4/2022" CONTEST OFFICIAL RULES

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. Caller number seven (7) to the Station, as determined by the Station in its sole discretion, will be entered for a chance to win. <u>*Time Delay*</u> <u>*Between Over-the-Air Analog Signal and Internet Broadcast*</u>: Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-theair signal.
