103-3 COUNTRY'S "DOWNLOAD OUR APP & WIN KENTUCKY KINGDOM TICKETS" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station WKDF ("Station"), owned and operated by Cumulus Radio LLC, 10 Music Circle East, Nashville, TN 37203, during normal business hours Monday through Friday or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the 103-3 Country's "Download Our App & Win Kentucky Kingdom Ticket" Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:
