103-3 COUNTRY'S "LADY A AT FIRSTBANK AMPHITHEATER" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station WKDF ("Station"), owned and operated by Cumulus Radio LLC located at, 10 Music Circle East, Nashville, TN 37203, during normal business hours Monday through Friday or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the 103-3 Country's "Lady A at the FirstBank Amphitheater" Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

 - Eligibility. Station assumes no responsibility for any fees or charges incurred for and associated with any text message sent to or from Station. Any and all fees arising out of the transmission of a text message shall be the sole responsibility of the entrant. Limit one (1) entry per person per phone number. Multiple participants are not permitted to share the same telephone number. Any attempt by any participant to submit more than one (1) entry by using multiple/different telephone phone numbers, identities, or any other methods will void that participant from further participation in the Contest.

Texting in will not increase your chances of winning.

Listeners may either (i) text in an entry using a mobile device or (ii) enter online, but not both methods. Limit one (1) entry per person/telephone number/email address, regardless of the method of entry chosen by a listener.
