103-3 COUNTRY'S "ARBY'S" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station WKDF ("Station"), owned and operated by Cumulus Radio LLC located at, 10 Music Circle East, Nashville, TN 37203, during available business hours Monday through Friday, on the Station website www.1033country.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the 103-3 Country's "Arby's" Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. (ii) <u>Text</u>: Send a text message with the keyword MEATS spelled correctly to 68683 during the Contest Period. All entries must be received by 11:59pm CT on July 25, 2021 to be eligible for a chance to win

a prize. Message and data rates may apply. Station has no responsibility for any fees or charges associated with any text messages entrant sends or receives in connection with the Contest. Entrant agrees to receive messages from Station from time to time relating to the Contest, the Station, and any Contest sponsor or prize provider Multiple participants are not permitted to share the same telephone number. Any attempt by any participant to submit more than one (1) entry by using multiple/different telephone phone numbers, identities, or any other methods will void that participant from further participation in the Contest.

Texting in will not increase your chances of winning.

Each day of the Contest listeners may either (i) text in an entry using a mobile device or (ii) enter online, but not both methods. Limit one (1) entry per person/telephone number/email address, regardless of the method of entry chosen by a listener.

- 4. **Winner Selection.** On or about 10:00am CT on July 26, 2021, Station will select five (5) potential winners in a random drawing from among all valid entries received by Station from both entry methods during the Contest Period. Each winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest. Failure to respond to the initial verification contact within three (3) days of notification will result in disqualification and forfeiture of the prize.
- 5. Verification of Potential Winner.
