103-3 COUNTRY'S "DAN + SHAY ALBUM" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station WKDF ("Station"), 10 Music Circle East, Nashville, TN 37203, during normal business hours Monday through Friday, on the Station website www.1033country.com or by sending a self-addressed, stamped envelope to the above address.

Eligibility. Multiple participants are not permitted to share the same telephone number. On or about 10:00am CT on August 16, 2021, Station will select three (3) entries for a Prize in a random drawing from among all valid entries received by Station from both entry methods during the Contest Period.
