1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. The approximate retail value ("ARV") of each prize is two-hundred dollars (\$200).

TOTAL ARV OF ALL CONTEST PRIZES IS: Two-Thousand Dollars (\$2000)
