## WKDF'S "BRELAND/ALANA SPRINGSTEEN BMI ROOFTOP ONLINE TICKET GIVE-A-WAY" CONTEST OFFICIAL RULES

The Station will conduct the WKDF'S "BRELAND/ALANA SPRINGSTEEN BMI ROOFTOP ONLINE TICKET GIVE-A-WAY" Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. Failure to respond to the initial verification contact within three (3) days of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.
