WODE'S "THE HAWK ULTIMATE BINGO BASH" OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station WODE (the "Station"), 2158 Avenue C, Suite 100, Bethlehem PA 18017, during available business hours Monday through Friday, Station website www.999thehawk.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct **WODE's "The Hawk Ultimate Bingo Bash"** Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

Eligibility. 2. Contest Period. The Contest will begin at or around 6:00 p.m., ET on Thursday, August 5, 2021 and will run through 2:59 p.m., ET on Sunday, October 3, 2021 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.

No prize will be substituted should anything be cancelled, postponed, or closed. Station and any sponsors make no representation or warranty about the safety of any events. By attending any of the events, each participant acknowledges and assumes all risks of attending any of the events, and any other the risks associated with any of the events.

- 3. **How to Enter.** There are several ways you can enter this Contest:
 - (i) <u>Musikfest</u>: Listeners may enter the Contest by playing bingo at the Hawk Tent during Musikfest located on at 101 Founder's Way on the south side of Bethlehem between August 5, 2021 through August 15, 2021 during designated times of 6:00 p.m. and 7:00 p.m. Up to twenty (20) people may receive a bingo card to play straight bingo. The first person to call straight bingo during the 6:00pm and 7:00 p.m. games will be designated winners who will win two (2) bingo seats at the grand finale Ultimate Bingo Bash on Sunday, October 3, 2021 at SteelStacks. Each winner will be notified directly that they are qualified to play bingo at the finale. There will be 66 seats awarded to the Ultimate Bingo Bash using this entry method; and/or
 - (ii) **QR Code | Online:** Scan the QR Code and completely fill out entry for a chance to win two (2) seats at Ultimate Bingo Bash. Listeners will be able to scan the QR code at three separate locations during the

Contest Period: (a) Musikfest during regular festival hours from August 5, 2021 through August 15th, 2021; (b) Lehigh Valley Honda on Lehigh Street in Allentown in their showroom during regular business hours from August 5, through October 1, 2021, and (c) Wheels of Time Car Show at Macungie Memorial Park in Macungie, PA on August 28, 2021 during regular festival hours. All fully completed entries must be received by 11:59 pm ET on September 30, 2021 to be eligible to win. Multiple participants are not permitted to share the same telephone number. Any attempt by any participant to submit more than one (1) entry by using multiple/different telephone phone numbers, identities, or any other methods will void that participant from further participation in the Contest. Entries will be shared with Lehigh Valley Honda. There will be 234 seats awarded to the Ultimate Bingo Bash using this entry method; and/or

- (iii) <u>Text</u>: Beginning August 30, 2021 and continuing through September 24, 2021, listen to 99.9 The Hawk (WODE) weekdays at 8:00amEST, 10:00amEST, 2:00pmEST and 5:00pmEST for the "Hawk Ultimate Bingo Bash" keyword to be announced. The first nine (9) listeners to text the correct keyword to the WODE shortcode 6-7-6-6-4 will automatically win one (1) seat at the Ultimate Bingo Bash on Sunday October 3, 2021. Winners will be instructed to contact the Station to claim their seat. There will be 36 seats given away each weekday. 720 seats total will be awarded to the Ultimate Bingo Bash using this entry method. Standard text messaging rates, as established by an individual's wireless carrier, may apply, and Station assumes no responsibility for any fees or charges incurred for and associated with any text message sent to or from Station. Any and all fees arising out of the transmission of a text message shall be the sole responsibility of the entrant. Limit one entry per personContest.
- How to PLAY: The Ultimate Bingo BASH Finale will be held on Sunday October 3, 2021 from 4. 9:00amEST to 2:00pmEST at SteelStacks located at 101 Founder's Way, Bethlehem, PA. There will be up to 1000 participants to play bingo at Oktoberfest. Bingo participants must check in with proper ID on Sunday by 8:45amEST to receive their bingo pack. Each packet will contain ten (10) bingo cards that are color-coded and marked with serial numbers of the bingo card to ensure integrity of the game. Ten (10) bingo games will be played on Sunday, October 3, 2021 for a variety of prizes. The 10th game will cover the entire card for the grand prize. Each sponsored game will be designated a certain winning bingo combination and will be announced prior to each game. Each player may only play one (1) set of cards. The color of bingo card will be announced prior to each game. Once the caller closes the game, any missed bingos become invalid. The final and tenth game will determine the vehicle winner. The final bingo game will be a blackout game where all the numbers on the bingo card must be covered. Bingo Game 3: The one (1) prize for bingo game 3 will be one (1) Dorney Park Haunt Prize Pack that includes four (4) admission tickets, four (4) meal tickets and four (4) fast pass wristbands and merchandise.

Bingo Game 4: The one (1) prize for bingo game 4 will be one (1) State Theatre Prize Pack that includes two (2) tickets to four (4) Hawk Sponsored Shows and a State Theatre gift card.

Bingo Game 5: The one (1) prize for bingo game 5 will be one (1) \$500 American Express.

Bingo Game 6: The one (1) prize for bingo game 6 will be one (1) \$500 American Express.

Bingo Game 7: The one (1) prize for bingo game 7 will be one men's watch or women's watch from Westgate Jewelers.

Bingo Game 8: The one (1) prize for bingo game 8 will be one (1) \$500 American Express.

Bingo Game 9: The one (1) prize for bingo game 9 will be one (1) \$500 American Express.

The Grand Prize. One (1) grand prize (the "Grand Prize") will be awarded in this Contest. The Grand Prize is a 24-month lease on the all-new Honda 2021 Honda Civic from Lehigh Valley Honda, specifications set forth below.
