CUMULUS MEDIA RADIO STATION GROUP ALLENTOWN CONTEST "HERSHEYPARK GIVEAWAY" OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of any of the participating radio stations set forth below (individually a "Station" and collectively, the "Stations"), owned or operated by Cumulus Media Radio Station Group Allentown, 2158 Avenue C, Suite 100, Bethlehem, PA 18017 during available business hours Monday through Friday, on Stations' websites, www.999thehawk.com, www.catcountry96.com, www.wlevradio.com, and lyfoxsports,com or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the Cumulus Media Radio Station Group Allentown Contest "Hersheypark Giveaway" (the "Contest") substantially as described in these rules. Participants acknowledge that the Contest is one (1) Lehigh Valley, PA Contest made up of five (5) Participating Stations, as outlined in the attached Exhibit A. Station is conducting this Contest concurrently and simultaneously on several Participating Stations that are located in Allentown, PA. By participating in this Allentown Contest, each participant agrees as follows:

- 1. NO PURCHASE IS NECESSARY TO ENTER OR WIN, A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY. Eligibility. This Allentown PA Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, excluding Florida and New York residents, age eighteen (18) years or older at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last 7 days or a prize valued at \$500 or more in the last 7 days, and whose immediate family members or household members have not won a prize from the Station in the last 7 days or a prize valued at \$500 or more in the last 7 days. The term "immediate family members" includes spouses, parents and step-parents, siblings and step-siblings, and children and stepchildren. The term "household members" refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Station's decisions, which are final and binding in all matters related to the Contest. Winning a prize is contingent upon fulfilling all requirements set forth herein.
- 2. **Contest Period**. The Contest entry period will begin at 5:00 am., ET on Monday, July 11, 2022 and will run weekdays (Monday through Friday) through 11:59 pm., ET on Friday, July 29, 2022, (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- 3. **How To Enter**: Listen to a Participating Station as listed at the bottom of these Contest Rules, weekdays during the Contest Period. Each Participating Station will announce a Secret Keyword at various times during the Contest Period (each a "Contest Round"), during the contest period, local time where a Participating Station is physically located. Then: (i) Text Entry Method. Send a text message to the corresponding station short code with the Secret Keyword correctly spelled before midnight local time that day. WODE shortcode is 6-7-6-6-4. WCTO shortcode is 6-8-2-5-5. WLEV shortcode is 6-8-6-8-3. WEEX shortcode is 6-4-6-3-6. All entries must be received by 11:59 on Friday, July 29, 2022, with the Secret Keyword to be eligible to win. You can enter this Contest once per week. Standard text messaging rates, as established by an individual's wireless carrier may apply, and Sponsor assumes no responsibility

for any fees or charges incurred for and associated with any text message sent to or from Sponsor. By entering the Lehigh Valley Contest using the texting entry method, you consent to the receipt of a bounceback confirmation text. Any and all fees arising out of the transmission of a text message shall be the sole responsibility of the entrant. Multiple participants are not permitted to share the same telephone number. Any attempt by any participant to submit additional entries by using multiple/different/alternate telephone phone numbers, identities, or any other method will void that participant from further participation in the Nationwide Contest. Use of any automated system to participate is prohibited and will result in disqualification. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible, inappropriate, or misdirected entries, all of which will be disqualified. In the event of a dispute as to any entry, the authorized account holder of the telephone number used to register will be deemed to be the participant. The "authorized account holder" is the natural person assigned the telephone number by the wireless carrier. Potential winner may be required to show proof of being the authorized account holder. All entries become the sole and exclusive property of Sponsor and will not be returned. No mail-in entries will be accepted. LIMIT ONE (1) ENTRY PER PERSON PER WEEK, REGARDLESS OF THE METHOD OF ENTRY CHOSEN BY A LISTENER. EACH CONTEST ROUND OF THE CONTEST, LISTENERS MAY EITHER (I) TEXT IN AN ENTRY INTO USING A MOBILE DEVICE OR (II) ENTER ONLINE, BUT NOT BOTH METHODS

- 4. Winner Selection. On or about 10am Mondays after one full week, the Station will select one (1) potential winner(s) for each station in a random drawing from among all valid entries received by Station during the Contest Period. Each winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.
- 5. Verification of Potential Winner. THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST. A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize. If a potential winner cannot be contacted, fails to sign and return the affidavit of eligibility and/or the liability/publicity release within the required time period (if applicable), or if the prize or prize notification is returned as undeliverable, potential winner forfeits prize. Grand Prize. Three (3) Grand prizes will be awarded in this Contest. There will be one winner chosen from all combined entries. (WODE,WLEV,WCTO/WWY,WEEX)

Each winner will receive a Hersheypark prize pack that includes; Four (4) tickets to Hersheypark in Hershey, PA, Four (4) meal tickets, Four (4) drink vouchers, and One (1) parking pass,

The approximate retail value ("ARV") of each prize is **FOUR-HUNDRED SIXTY-FIVE DOLLARS** (\$465). **TOTAL ARV OF ALL CONTEST PRIZES IS: ONE-THOUSAND, THREE HUNDRED, NINETY-FIVE DOLLARS** (\$1395).

Winner is responsible for all taxes associated with prize receipt and/or use. Any attempt by any person to deliberately undermine the 4 legitimate operation of the Contest may be a violation of criminal and civil law, and, should such an attempt be made, Station reserves the right to seek damages from any such person to the fullest extent permitted by law. Station's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
- 11. **Limitations of Liability**. The Released Parties are not responsible for: (a) any incorrect or inaccurate information, whether caused by Station, Sponsor(s), entrants, printing errors or by any of the equipment or programming associated with or utilized in the Contest; (b) technical failures of any kind, including but not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software; (c) unauthorized human intervention in any part of the entry process or the Contest; (d) technical or human error that may occur in the administration of the Contest or the processing of entries; or (e) any injury or damage to persons or property that may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Contest or receipt or use, non-use or misuse of any prize. Entrant agrees that**: (a) any and all disputes, claims and causes of action arising out of or connected with this Contest, or any prizes awarded, shall be resolved individually, without resort to any form of class action; (b) any and all disputes, claims and causes of action arising out of or connected with this Contest, or any prizes awarded, shall be resolved exclusively by the United States District Court or the appropriate state court located in the Station's listening area; (c) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Contest, but in no event attorneys' fees; and (d) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE MAY NOT APPLY TO YOU. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of entrant and Station in connection with the Contest, shall be governed by, and construed in accordance with, the laws of the state in which the Station is located, without giving effect to any choice of law or conflict of law rules (whether of the state in which the Station is located or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the state in which the Station is located.

and assumes no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to Station's website.
