ALT 92.3'S "MARC BROUSSARD" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station WZRH-FM ("Station"), owned and operated by Cumulus Radio, LLC, 201 St. Charles Ave, Suite 201, New Orleans, LA 70170, during available business hours Monday through Friday, Station website www.alt923.com, or by sending a self-addressed, stamped envelope to the above address.
