NASH ICON 106.1'S "KANE-TOBER" CONTEST OFFICIAL RULES

The Station will conduct the **NASH Icon 106.1's "Kane-tober"** Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. All entries must be received by 11:59am CT on Thursday, October 21, 2021 to be eligible for the prize drawing. Limit one (1) entry per person per day, regardless of how many email addresses a person may possess and use. Multiple participants are not permitted to share the same email address. Any attempt by any participant to submit more than one (1) entry per day by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entry and the participant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. Station is not responsible for lost, late, incomplete, invalid, unintelligible, inappropriate or misdirected registrations, all of which will be disqualified. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the participant. The "authorized account holder" is the natural person assigned the telephone number by the wireless carrier or an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. <u>Text</u>: Listeners must listen for a new keyword given every Friday during the Contest Period between the hours of 12pm-3pm CST and text the keyword to 68255. All entries must be received by 11:59am CT on Thursday, October 21, 2021 to be eligible for the prize drawing. **Standard text messaging rates, as established by an individual's wireless carrier, may apply, and Station assumes no responsibility for any fees or charges incurred for and associated with any text message sent to or from Station. Any and all fees arising out of the transmission of a text message shall be the sole responsibility of the entrant. Multiple participants are not permitted to share the same telephone number. Any attempt by any participant to submit more than one (1) entry by using multiple/different telephone phone numbers, identities, or any other methods will void that participant from further participation in the Contest.**

- 4. **Winner Selection.** On or about 12:00pm CT on Thursday, October 21, 2021, the Station will select (7) entries for the prize in a random drawing from among all valid entries received by Station during the Contest Period. Failure to respond to the initial verification contact within three (3) days of notification will result in disqualification and forfeiture of the prize.
