- 4. **Winner Selection.** On Thursday, July 1, 2021, the Station will select one (1) winner in a random drawing from all valid entries received during the Contest Period. Each winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winners are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within twelve (12) hours of notification will result in disqualification and forfeiture of the prize. Unclaimed prizes may not be awarded.
