98.3 THE VIBE "DRAKE WRITE IT DOWN" CONTEST OFFICIAL RULES

The Station will conduct the **98.3 The Vibe's "Drake Write It Down"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility.  - C. All entries must be received by 11:59 PM CT on June 16, 2023 to be eligible for a chance to win a prize. Entrant represents and warrants that the entry (and accompanying photograph) is not indecent, lewd, offensive, defamatory, profane, or in bad taste and does not contain material that may infringe or violate any laws or anyone's rights.. The winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification or failure to claim the prize within three (3) days of verification as a winner may result in disqualification and forfeiture of the prize.
