

KXKL (KOOL 105) "DOLLAR BILL GAME" Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED.

THE CONTEST

- a. The KOOL105 ("Station") "Dollar Bill Game" contest (the "Contest") will begin Monday, August 17, 2020 and end Friday, October 9, 2020 (the "Contest Period", Contest will be played Monday - Friday only during contest period. Contest will be played four (4) times per day between 8:00AM MT and 6:00PM MT on Monday, Tuesday, Thursday and Friday during contest period. Contest will be played in the 8:00am MT, 9:00AM MT, 10:00AM MT, 11:00AM MT, 12:00PM MT, 1:00PM MT, 2:00PM MT, 3:00PM MT and 4:00PM MT hours on Wednesday's ONLY during contest period. On-air personality will prompt listeners to call (303) 531-0105 who have a One Dollar United States of America Federal Reserve Note that has a 1-0-5 in the alphanumeric Serial Number in any order. On-air personality will take Caller 10. Caller 10 will have to send a photo of their One Dollar Bill with a 1-0-5 in the alphanumeric Serial Number to jim@kool105.com where it will be verified. (The "0" is a zero not the letter O). On-air personality will attach the photo of the One Dollar Bill alphanumeric Serial Number on the winner's prize sheet. Alphanumeric Serial Number on the One Dollar United States of America Federal Reserve Note will be verified by radio station personnel that it matches identically the alphanumeric serial number written down by the on-air personality. If radio station personnel do not receive the photo of the One Dollar United States of America Federal Reserve Note with the alphanumeric serial number taken down by the on-air personality they will forfeit their prize. \$100 prize will be in the form of a Company check and will take 3-4 weeks to process and will be mailed to the winner's address given to the on-air personality at time of verified win. All winners will have to fill out and send to the radio station a W-9 form before the check process can begin.
- b. PRIZES: The \$100 prize will be a check.
- c. The Station is not responsible for telephone service outages, delays, busy signals, equipment malfunctions and any other technological difficulties that may prevent an individual from completing his/her telephone call.

ELIGIBILITY RESTRICTIONS

- a. The Contest is open to all KXKL KOOL 105 listeners who are 18 years of age or older and who legally reside in the state of Colorado. Employees of KXKL (the "Station"), its licensee, its corporate parents, subsidiaries, and affiliates, its advertising agencies, participating sponsors/promotional partners, other radio stations in the Denver metropolitan area and the members of their immediate families and/or households are ineligible to participate or win. This contest is subject to all applicable federal, state and local laws and regulations.
- b. Contestants may only win twice <u>per household address</u> every CALENDAR month for daily giveaways such as concert tickets, gift cards, movie passes, etc. Contestants can

only win once per month for a MAJOR STATION contest unless otherwise noted in the Rules.

- c. Contestants are required to provide truthful information and the Station will reject and delete any entry that it discovers to be false or fraudulent. The Station will disqualify any entry from individuals who do not meet the eligibility requirements, and the Station will delete any entry received from persons under the age of 13 in compliance with the Children's Online Privacy Protection Act.
- d. Decisions of the Station management with respect to the Contest are final.
- e. All prizes or prize certificates may be picked up at the Pepsi Center East Reception Monday Friday only between 9a-5p. Certain prizes will be mailed to the winner and winner will be notified of this by a member of the KSE Radio promotion department. The winner will forfeit any prize or prize certificate not claimed within thirty (30) days of winning. This 30-day rule does not apply to prizes that are awarded in the form of a Company check. In the event a prize or prize certificate is mailed to the winner, it will be with the prior written consent of the winner and therefore, winner assumes the risk of its loss. The Station is not responsible for the safe arrival of a prize or prize certificate.
- f. There is no substitution, transfer, or cash equivalent for prizes, except that KXKL- KOOL 105 may, at its sole discretion, substitute prizes of comparable value or cash. The prizes are expressly limited to the item(s) listed above and do not include taxes, gratuities or any other expenses. Other restrictions may apply.

WINNER SELECTION AND NOTIFICATION

Decisions of the Station management with respect to the contest are final.

CONDITIONS

- a. Payments of all federal, state and local taxes are solely the responsibility of the winners. All winners will be required to sign an IRS Form W-9 or the equivalent if they win \$600 or more. Failure to provide an accurate and complete Social Security Number, if required, is a violation of federal law and will result in forfeiture of prize.
- b. By participating in the Contest, the winner agrees to have the winner's name, voice, or likeness used in any advertising or broadcasting material relating to this contest without additional financial or other compensation, and, where legal, to sign a publicity release confirming such consent prior to acceptance of the prize.
- c. Prior to awarding any prize or prize certificate, the Station in its sole discretion may require contest winners (and their travel companions, if any) to sign a liability release, agreeing to hold the Station, its corporate licensee, its parent, subsidiary and affiliated corporations, and the officers, shareholders, directors, employees, agents and representatives of each of them harmless against any and all claims or liability arising directly or indirectly from the prize or participation in the Contest.
- d. The Station, in its sole discretion, reserves the right to disqualify any person tampering with the entry process, the operation of the Station's Web Site or is otherwise in violation of the rules. It further reserves the right to cancel, terminate or modify the Contest if it is not capable of completion as planned, including infection by computer virus, bugs, tampering, unauthorized intervention or technical failures of any sort.

- e. The Station reserves the right to make changes in the rules of the Contest, including the substitution of a prize or equivalent value, which will become effective upon announcement. If due to circumstances beyond the control of the Station, any competition or prize-related event is delayed, rescheduled, postponed, cancelled or has a change of venue, the Station reserves the right, but not the obligation, to cancel or modify the Contest and shall not be required to award a substitute prize.
- f. Failure to comply with the Contest rules may result in a contestant's disqualification, solely at the discretion of the Station.
- g. The Station is not responsible for typographical or other errors in the printing, the offering or the administration of the Contest, or in the announcement of a prize.
